

SUMMARY ANNUAL REPORT

OPERATING ENGINEERS PUBLIC AND MISCELLANEOUS EMPLOYEES HEALTH AND WELFARE TRUST FUND

This is a summary of the annual report of the Operating Engineers Public and Miscellaneous Employees Health and Welfare Trust Fund, E.I.N. 94-2567865, Plan No. 501, for the year ended December 31, 2018. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Union Labor Life Insurance Company, Kaiser Foundation Health Plan, Inc., and Reliastar Life Insurance Company to provide certain benefits incurred under the terms of the plan. The total premiums paid for the plan year ended December 31, 2018 was \$2,851,673.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$15,793,429 as of December 31, 2018, compared to \$14,407,306 as of January 1, 2018. During the plan year, the plan experienced a increase in its net assets of \$1,386,123. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$20,708,709 including employer contributions of \$18,622,295, participant contributions of \$716,864, gains from investments of \$153,004 and other income of \$1,216,546.

Plan expenses were \$19,322,586. These expenses included \$1,114,227 in administrative expenses and \$18,208,359 in benefits paid to or for participants and beneficiaries.

You have the right to receive a copy of the full annual report, or any part thereof, on request. The items listed below are included in that report:

1. An independent auditors' report;
2. financial information and information on payments to service providers;
3. information regarding any common or collective trusts, pooled separate accounts, master trusts or 103-12 investment entities in which the plan participates;
4. assets held for investment;
5. transactions in excess of 5% of the plan assets; and
6. insurance information, including sales commissions paid by insurance carriers.

If you request a copy of the full annual report from the plan administrator, these two statements and accompanying notes will be included as part of that report. The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.

You also have the legally protected right to examine the annual report at the main office of the plan (1600 Harbor Bay Parkway, Alameda, CA 94502) and at the U.S. Department of Labor in Washington, D.C., or to obtain a copy from the U.S. Department of Labor upon payment of copying costs.
